MINUTES OF PREVIOUS MEETING:

The minutes of the previous meeting held on 12 October 2011 were read, confirmed and signed.

BUSINESS ARISING:

In regard to the weather monitoring station an extract taken out of the approval was provided (copy attached) which does not make any mention that the station needs to be in place for twelve months prior to any work being undertaken. Mick Heppleston wishes more clarification on this and will be asking Kane Winword from the Department of Planning.

Brian Jenns brought up the issue of the state of the road. No work has been done since the Ardmore Park approval. It was asked of Council whether this was because they were waiting for Multiquip Quarries to do the upgrade. It was mentioned that Council should still maintain the road until the upgrade was carried out.

The spraying of the tussock was undertaken.

Don Elder sent the letter to the Bungonia Progress Association, as promised.

GENERAL BUSINESS:

Steve Mikosic advised the committee that work on establishing the quarry operations, as well as the road upgrade and bypass was still ongoing and quotes were being obtained. The company is planning to start the bypass by the end of this year.

It was asked how long the roadworks would take to complete once commenced. Steve said they would take approximately four to six months, weather permitting and after the bypass is completed.

Further discussions took place on the construction of the roads and Steve said he would provide details to the committee members regarding the roadworks by 31st May. These will be discussed at the next meeting.

Multiquip Quarries has been issued with a 110 megalitre licence per year.

Note: Deposited dust is assessed as insoluble solids as defined by Standards Australia, 1991, AS 3580.10.1-1991: Methods for Sampling and Analysis of Ambient Air - Determination of Particulates - Deposited Matter -Gravimetric Method.

Operating Conditions

 The Proponent shall ensure any visible air pollution generated by the project is assessed regularly, and that quarrying operations are relocated, modified, and/or stopped as required to minimise air quality impacts on privately owned land.

Air Quality Monitoring

- The Proponent shall prepare and implement an Air Quality Monitoring Program for the project to the satisfaction of the Director-General. This program shall:
 - be prepared in consultation with DECC, and be submitted to the Director-General for approval prior to carrying out any development on site;
 - (b) include details of how the air quality performance of the project would be monitored, and include a protocol for evaluating compliance with the relevant air quality criteria in this approval.

METEOROLOGICAL MONITORING

During the life of the project, the Proponent shall ensure that there is a suitable meteorological station
in the vicinity of the site that complies with the requirements in the Approved Methods for Sampling of
Air Pollutants in New South Wales guideline.

WATER

Water Supply

11. The Proponent shall ensure that it has sufficient water for all stages of the project, and if necessary, adjust the scale of operations to match its water supply.

Note: The Proponent is required to obtain necessary water licences for the project under the Water Act 1912 and/or Water Management Act 2000.

Discharges

12. The Proponent shall not discharge any water from the quarry or its associated operations except in accordance with an EPL.

Water Management and Monitoring

- 13. The Proponent shall prepare and implement a Water Management Plan for the project to the satisfaction of the Director-General. This plan must:
 - be prepared in consultation with DWE, DECC and SCA, and be submitted to the Director-General for approval prior to carrying out any development on site; and
 - (b) include a:
 - Site Water Balance;
 - Erosion and Sediment Control Plan;
 - Surface Water Monitoring Program;
 - Groundwater Monitoring Program; and
 - Surface and Groundwater Response Plan.
- 14. The Site Water Balance must:
 - (a) include details of:
 - sources and security of water supply;
 - water use on site:
 - water management on site, including the location and capacity of water storages on site and the means of access;
 - off-site water transfers; and
 - reporting procedures; and
 - (b) investigate and describe measures to minimise water use by the project.
- 15. The Erosion and Sediment Control Plan must:
 - (a) be consistent with the requirements of Managing Urban Stormwater: Soils and Construction,
